#### 1. Weekly Property Reports

The Clerk reported that the Maintenance Officer has carried out weekly checks of play areas and properties. She continued to report that the Maintenance Officer had removed a fallen tree from the Recreation Ground. He has also moved and concreted in a bin into the middle of the gap in the fence which a car had used to gain access to the football pitches causing some damage. The incident has been reported to the Police. A part section of fencing which had been removed creating the gap to be put back. There is a rough idea of the number plate of the car that has been put forward by someone who has also experienced similar activity on their land, however the Police are unable to use the information provided to the Council. A youth is also climbing the tennis court fencing to access the light controls to provide light to the M.U.G.A. A 45 degree angled additional piece of fence could be added to the top of the

existing fence to make climbing over more difficult. Prices to be sought to have this carried out. The Clerk to find out if owners of other courts have had the issue with people climbing over the fence and if so, how have they dealt with it.

#### 1.Covid-19 update

Parish Council meetings are now being held in person at Mandeville Hall. Group meetings will continue to be held virtually for the time being. Most hall hirers are returning from 17<sup>th</sup> May 2021.

## 2. Update on the Gardiner Memorial Hall Refurbishment Project

Amendments to the planning application have now been submitted and are at the consultation stage. Funding is now in place for the first phase, the refurbishment of the existing hall. The Project Team has gone out to tender for the first phase. Video filming will take place tomorrow in order to submit a video to support an expression of interest application for the National Lottery Community Grants for All. The outcome of this application, for which there are two stages is not likely to be known until towards the end of the year. Crowd funding could be launched at the proposed village/carnival event in September.

3.Consideration of Third-Party Funding for AMEY Grant in the sum of £8,600.00 To release the £80,000 grant from AMEY for the Gardiner Memorial Hall a Third-Party Contribution is required to be paid. The Parish Council can be its own Third- Party Contributor.

Michael Swift proposed that the Council should fund the Third-Party Contribution of £8,600.00 from General Reserves. The proposal was seconded by Brenda Wilson and the Council voted unanimously to approve the proposal.
