Hi Katherine,

Thanks for getting in touch. I'm happy to help provide some background for your councillors ahead of the meeting on 24 February. Please see responses to your questions below:

- **Would the previous decision to turn down funding go against a new application?**

No — previous decisions don't negatively affect a new submission. Each round is assessed on its own merits, based on current criteria and local support at the time of application.

- **Would the earlier consultation result (a small majority against 20mph) go against an application?**

Not necessarily. What matters is the evidence of support at the time of the new application. If attitudes have changed or councillors feel a new proposal is justified, that earlier result doesn't prevent the parish from applying again.

- **If a smaller section of the village were included (e.g., Buntings Path / The Causeway), would the existing LHI-funded flashing signs need to be removed?**

No. To future-proof the signs, we would ensure they do not include sub-plates that reference a specific speed limit. Without speed-specific sub-plates, flashing signs can remain in place and continue to operate within a 20 mph speed limit if it was to change.

- **Can a small part of the village be done?**

Yes, partial-area schemes are possible. Many parishes choose to phase 20mph implementation or focus on priority streets first where there is clearer support or more demonstrable need.

- **Have there been positive outcomes from other 20mph villages (pollution, accidents, etc.)?**

Yes, schemes generally report lower speeds, improved driver behaviour, and greater perception of safety. Once schemes have had longer to settle in, we would hope parishes are able to provide data that supports the evidence that indicates small reductions in traffic can lower the possibility of collisions occurring and is likely to reduce the severity of any that do happen.

- **Would another consultation be required?**

Yes, we would expect a fresh consultation to support the new application, especially given the time since the last one and the number of new councillors/residents.

Demonstrating current local support is a key part of the assessment process. Any

new proposal would also require a formal consultation once approved by the parish.

- **If funding were approved this round, what is the earliest signage could be installed?**

Delivery usually follows the standard implementation programme after awards are confirmed, typically within 18 months of being awarded funding. 20mph schemes often require Delegated Decision after formal consultation which can add to the timescales.

- **Will there be another funding round for 27/28?**

At present, we expect the Local Highways Improvement (LHI) funding rounds to continue on an annual basis. However, as with all local government programmes, formal confirmation for the 2027/28 round will only be possible once the Council's budget is set for that year and plans with the Local Government Review.

**Did Highways say that 20mph was not possible along Swaffham Road?**

My understanding is that the earlier discussion for Swaffham Road, noted we could move the terminal to be between Heath Road and Reach Road, keeping Swaffham Road and Heath Road as existing 30mph. Making the 30mph on Swaffham Road, around 600m, which would be enforceable by Police.

If the parish wishes to revisit Swaffham Road as part of a refreshed proposal, we can review it again with updated information.

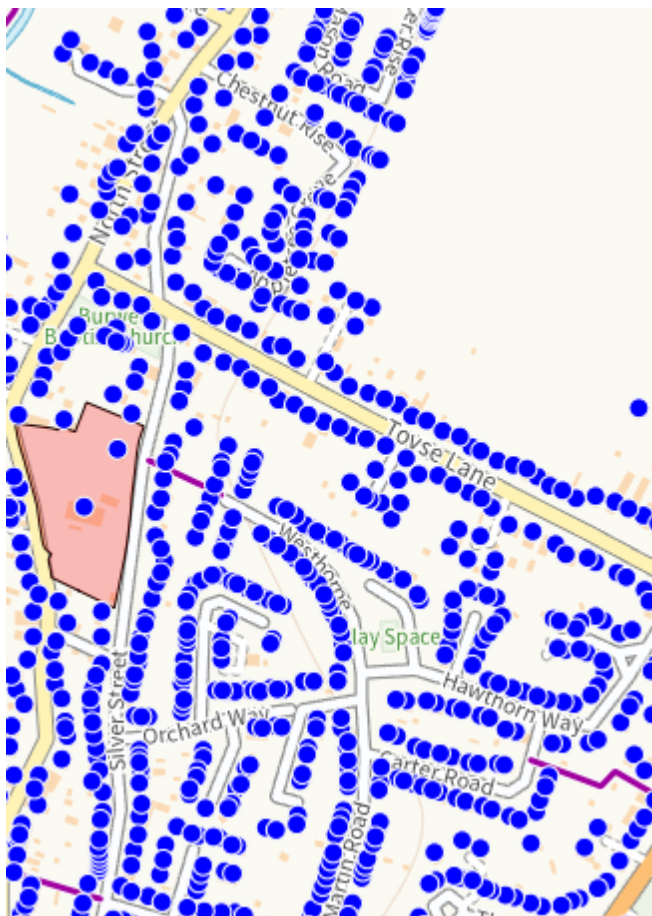

Hi Michael/Carole,

Would either of you have time for a quick chat today or could answer the questions below? I'm just after some history from when we applied for the 20mph funding before. We will take it to a vote in our meeting on the 24<sup>th</sup> February, if a councillor proposes we should, but councillors would like answers to these questions so they have fuller information. We have 7 new councillors who have never been involved in the 20 mph campaign.

1. Would the fact we turned down the money previously go against an application?
2. Would the previous consultation we did where a small majority decided no to 20 mph go against an application?
3. If they applied for 20mph for a smaller portion of the village including Buntings Path and the Causeway would we need to remove the 20mph flashing signs that we have approved LHI funding for?
4. Can a small part of the village be done? – example attached.
5. Have you seen any positive outcomes from the villages that have already gone 20mph e.g. reduction in pollution/accidents?
6. Would you expect another consultation with resident to be carried out?
7. If we applied for funding this round and were successful what is the earliest that signage etc would be likely to go up?
8. Will there be another round of funding for 27/28?
9. Did Highways say that 20mph was not possible along Swaffham Road?
